The Board of Directors have, at their meeting held today (i.e 24th August 2020), approved the following proposals:

1. Sixty Third Annual General Meeting

The Sixty Third Annual General Meeting ("**AGM**") of the Members of the Company will be held on **Saturday, 26th September 2020** at **4.00 p.m** through Video Conferencing ("**VC**") / Other Audio Visual Means ("**OAVM**").

2. Fixation of Record Date

The Board of Directors have fixed **Saturday, 19th September 2020** as the Record Date for the purpose of payment of dividend and also as cut-off date for the purpose of e-Voting.

3. Appointment of Independent Directors / Managing Director

The Board of Directors have made the following recommendations with regard to the appointment of Independent Directors / Managing Director, subject to the approval of the members at the ensuing Annual General Meeting.

- a. Appointment of Smt Priya Bhansali (DIN: 00195848), as an Independent Director, not liable to retire by rotation, for a second term of five consecutive years from 28th September 2020 to 27th September 2025.
- b. Appointment of Sri K P Ramakrishnan (DIN: 07029959), as an Independent Director, not liable to retire by rotation, for a second term of five consecutive years from 28th September 2020 to 27th September 2025.
- c. Re-appointment of Sri M Balasubramaniam, Vice Chairman and Managing Director, for a period of five (5) consecutive years with effect from 29th September 2020, subject to retirement by rotation.

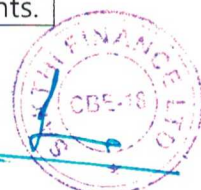
