#### Request for PAN, e-mail, phone and bank account details

We wish to write this letter for the following purposes:

#### 1. Requirement of furnishing copy of your PAN Card

Shareholders may note that the Income Tax Act 1961 ("IT Act"), as amended by the Finance Act 2020, mandates that dividends paid or distributed by a Company after 1 April 2020 shall be taxable in the hands of shareholders. Hence shareholders are requested to send their e-mail ID to the Company / RTA, as the case may be.

#### 3. Requirement of furnishing your bank account details

Due to the outbreak of Covid-19 globally, the delivery of physical dividend warrants by post may be delayed within India and abroad. Further, the validity of dividend warrants is for a period of 3 months only from the date of issue. The shareholders may find it difficult to receive and encash the dividend warrants in time. In order to overcome such a situation, we request you to furnish your bank account details along with the documentary proof so that the dividends, if any, declared, will be credited to your bank account.
